Sub: To investigate and to take action against the students and anti-social elements in the incident which took place on 24.03.2010 in the Auditorium of NIT, Warangal – Reg.

Since, some of Student Council members of Institute wanted to have an open discussion in the presence of students about the problems faced by them, a student meeting was convened in the Institute Auditorium at 4.00 PM on 24.03.2010. The assistance of local police was sought for the smooth conduct of the meeting. The meeting was attended by not only students and staff of the Institute but also some media persons and outsiders. In the meeting, students posed certain questions to the Director of the Institute and he has answered them. The Director has promised to solve the so-called problems alleged to have been faced by the students of the Institute in due course of time. Suddenly, some of the persons who attended the meeting started giving slogans demanding him to resign with immediate effect and a pandemonium broke out in the meeting. Meanwhile, some of the un-social elements found to have closed the doors of the Auditorium and did-not allow him and me. We were forced to stand for almost three hours in the Auditorium. Meanwhile, some persons who were present there brought a white blank paper and forcibly obtained signature of the Director on it. Even after signing on the white paper, they did-not allow him to leave the Auditorium and wrongfully confined us and made preparations to assault us. While things stood thus, some persons brought a typed paper which purported to contain the text of resignation and insisted the Director to sign on it. When he did not agree for the same, they forced him to sign on it. In the given circumstances he had no option but to sign on it in order to get out of the situation and from the Auditorium and he signed on said papers under coercion and duress.

As seen from the events that took place for the last two days, it is very clear that some anti-social elements who are working against the interest of the Institute are spreading rumours and misinformation among the students and instigating them against the management and it appears that a conspiracy is hatched to disturb the peace and harmony of the Institute. In the given circumstances, I request you to investigate into the matter and find out and identify the anti-social elements and the students were involved in the above incident.
